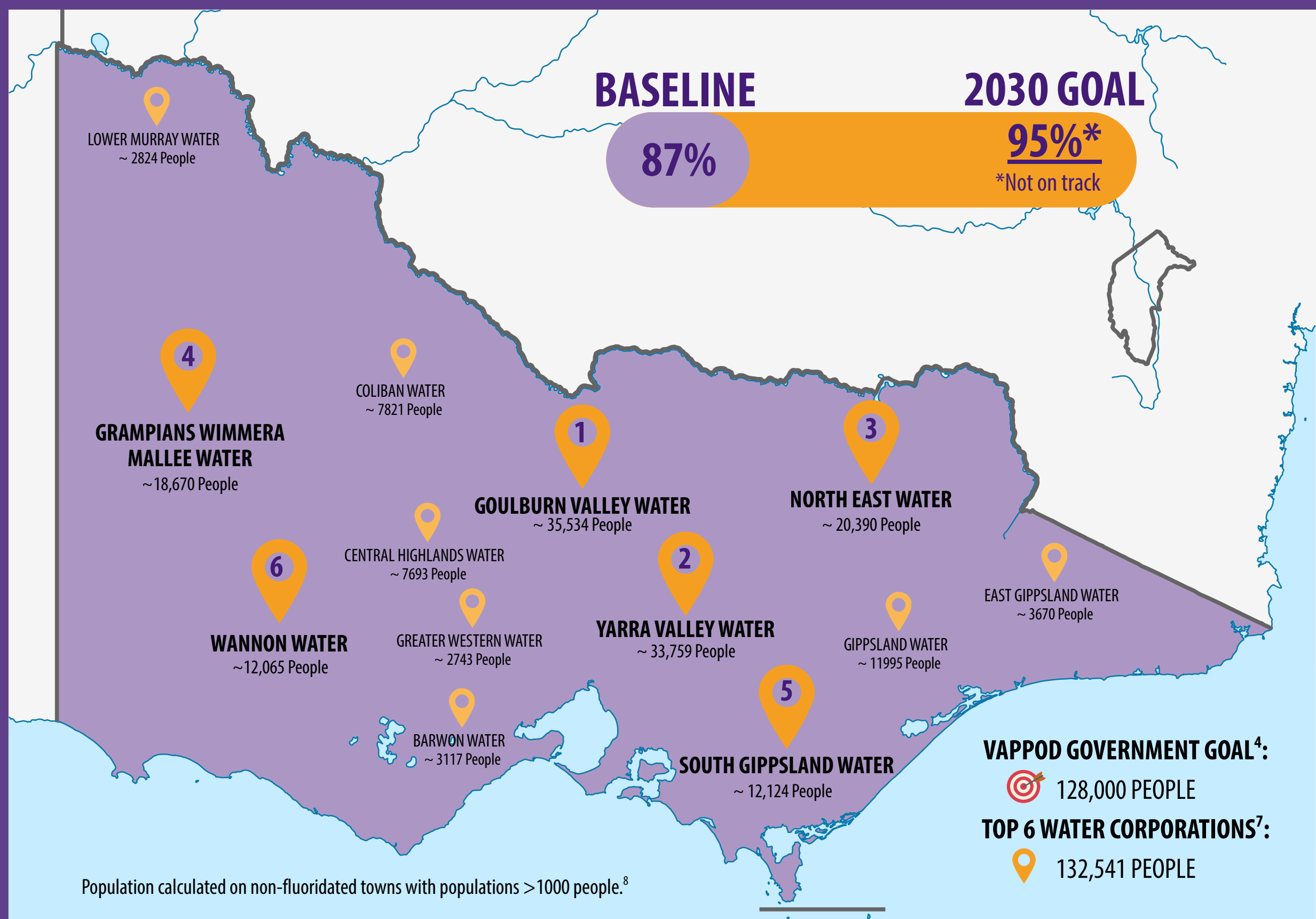
# VICTORIA'S COMMITMENT TO ORAL HEALTH: WHY AREN'T WE THERE YET?

## EXECUTIVE SUMMARY

- Fluoridation is endorsed by the World Health Organization, NHMRC, and the Australian Dental Association as a safe and effective public health measure.<sup>1-3</sup>
- Fluoridated water reduces tooth decay by 26-44% in children and 27% in adults.<sup>2</sup>
- The Victorian Government has committed to improving oral health through expanded access to fluoridated water.<sup>4</sup>
- The Victorian Action Plan to Prevent Oral Disease (VAPPD) 2020–2030 aims to increase fluoridation coverage from 87% to 95% of rural and regional Victorians (~128,000 people).<sup>4</sup>
- At the half-way point of the VAPPD, 73 rural towns (with populations over 1,000) still remain unfluoridated, affecting ~150,000 people.<sup>5</sup>
- These areas show higher rates of dental decay and preventable hospitalisations, especially in children aged 0-9.<sup>6</sup>
